## Documents required in applying for entrance

Original and copy of a national passport, or in the case of person who is stateless or otherwise lacking a passport, some other document which can provide certification for a stateless person with a type D visa (04/12) for persons with entry visas issued by consular institutions of Ukraine abroad on the basis of invitations to study, unless otherwise provided for by international treaties of Ukraine. If available, originals and copies of the following documents should be submitted:
  - a certificate of permanent or temporary residence in Ukraine;
  - a diplomatic card of the Ministry of Foreign Affairs of Ukraine.
- 3. Original and copy of a Master's or Specialist's diploma. A Master's or Specialist's diploma not issued in Ukraine must be certified and legalized (apostilled). A notarized translation must be provided along with it.
- 4. The original as well as a copy of the master's or specialist's diploma supplement document, containing a transcript of grades obtained by the

studentduring the course of the master's or specialist's program. If this diploma supplement was issued by an institution outside of Ukraine, it must be certified and legalized (apostilled), and must be accompanied by a notarized translation into Ukrainian.

## Stipulations for entry and for stays on the territory of Ukraine

Foreigners wishing to study in Ukraine must obtain a long-term type D visa (with an indication that the purpose of the stay is for studies) in accordance with established procedures, unless otherwise established by the legislation of Ukraine.

Foreigners who have come to Ukraine for study purposes are required to obtain a temporary residence permit in Ukraine, and must be in compliance with the deadlines set by law for the processing of such documents.

### Registration of a Temporary Residence Permit in Ukraine

In order to obtain a Temporary Residence Permit in Ukraine, a foreign citizen must submit the documents listed below to the following address within three days of their arrival in Ukraine:
