At various stages of Ukraine's existence, government authorities, local communities and society in general took specific positions toward crime and punishment which were largely a function of the linkage of individuals to the church, and of the church to the state. It is confirmed that the Ukrainian legal tradition in relation to crime and punishment was developed and put into operation principally under the influence of the western world and basically had a humane attitude with respect to criminals and punishment.
